**The Windham Town Beach is for residents/residential taxpayers of the Town of Windham only and is under the supervision of the Parks and Recreation Director.**

**RULES**

1. Current annual beach pass is required. Passes may be obtained at the beach.
  - Residents may bring guests, but must accompany the guest at all times.
  - Number of guests permitted may be limited at the discretion of the lifeguards based on occupancy.
  - Group use of the beach requires advanced approval from the Parks and Recreation Director.
2. Access the beach through the walkway by the guard house only.
3. Swimming is permitted when lifeguards are on duty during beach hours and within the defined swim lines. If lifeguards are not on duty, it is swim at your own risk.
4. Children must be supervised at all times.
  - Babies/toddlers must be kept within arm's length of adult in water and around water at all times. Swim diaper must be worn.
  - Children under 12 must be accompanied by an adult.
  - Adult must be able to stand if bringing child out over his/her head, even with a flotation device.
5. The following are **prohibited** from the town beach:
  - Any access to the Fire Dept. dock
  - Fishing from the beach, beach dock or raft
  - Smoking/vaping on beach or in parking lot (per Reg. WIN 3:00:14:07)
  - Alcohol and narcotics
  - Pets (per Reg. WIN 2:06:21:04)
  - Feeding ducks or other wildlife
  - Glass containers
  - Profane language or improper behavior
  - Plastic rafts/tubes- exception for baby/infant floats with seat attached
  - Boogie boards
  - Diving or running on the dock
  - Fires
  - Littering
  - Hanging on buoys or lifelines

6. The raft is only for swimmers capable of swimming without assistance.
  - Not allowed at raft: running, pushing, back dives, flipping, swimming under the raft or behind it.
  - Flotation devices are not allowed at the raft.
7. Coast Guard approved watercraft (paddle boards, kayaks, etc..) may be launched from the Town Beach within the boat launch area only and from dawn to dusk.
  - Coast Guard approved watercraft are any craft governed by NH Fish and Game and the US Coast Guard and which can be carried from vehicle to launch site.
  - All such crafts must adhere to NH Fish and Game and US Coast Guard rules including, but not limited to, having an approved Personal Flotation Device on the craft for each rider.
  - Watercraft must be carried through the walkway, not over the boat launch gate.
  - At no time may any non-Coast Guard approved craft be launched from the beach area or the boat launch- including tubes, homemade rafts, etc.
8. Personal flotation devices (PFD's) must be Coast Guard approved and are only permitted when the beach is lightly attended, at the discretion of the lifeguards.
9. The Parks and Recreation Department will not be held responsible for any lost or stolen items.
10. All persons must respectfully comply with lifeguard requests at all times or will be asked to leave the facility.

**Beach passes may be revoked at the discretion of the Parks and Recreation Director.**
